THE MINORITY-COMPETENCE-NETWORK

The Minority-Competence-Network was established in 2020 and gathers all national and regional minorities of the German-Danish border region. These minorities are: the Danish minority in Germany, the German minority in Denmark, the North Frisian minority and the German Sinti and Roma. The aim of the network is to encourage actions for autochthonous minorities in the region and abroad. Minorities across Europe are all different. Nevertheless, often similar issues are faced or topics addressed. We connect minorities across Europe to encourage discussions, foster contact and to enable minority members to learn from others. We strongly believe that all members of minorities can learn from each other and that our location in the German-Danish border region provides a fertile ground for connecting, meeting and discussing.

OUR OFFER TO YOU

We drafted a programme to welcome you to our region. As we were told, you are especially interested in the links between minority identity and language and the role the minority's churches can play. This is a very relevant topic among various minorities, because nation states can change their policies towards minorities' churches. Therefore, we would like to show you how churches and their institutions and minorities take part in Denmark and Germany and how we can compare this situation with the Swedish-speaking Finns.

We want to discuss the basics of being a minority and what it means in the every day life and within a religious context. How are language, identity and religion liked to each other? Are there any special approaches within your community? What does it mean to you emotionally to sing songs and to pray in your mother tongue?

The German-Danish border region often names itself as best practice example for minority issues in Europe, it would be interesting to discuss whether this actually is the case or not. What can we learn from you? What can you learn from us? We hope to create a nurturing environment to discuss minority matters openly and successfully.
